<b>Students with fewer <i>opportunities</i></b>	<b>100 EUR one-time payment</b>
<b>Support for inclusion (so-called <i>inclusion support</i> )</b> - separate application of students through their home institution to the Agency after the selection of candidates in the competition, and before leaving for mobility	increased financial support for additional actual costs of mobility participants with specific physical, mental or health circumstances (it is necessary to fill in a special application form available on website: <a href="#">2023/Project implementation/Contracts and annexes</a>

**Travel costs in student mobility**

<b>Students <u>without support for travel</u> based on the calculation of travel distance ( <i>distance band</i> )</b>	<b>allowance for "green travel " :</b> additional one-time payment of 50 EUR if "green means" of transport are used for the trip + it is possible to finance up to 4 additional travel days (total for the return trip = trip in both directions)
<b>Students and recent graduates <u>with travel support based on</u> distance <i>band</i> calculation</b>	<b>contribution according to the distance band calculation</b> (regular or "green" depending on the type of transport - see table below): <b>mandatory:</b> for students with fewer opportunities on all short-term mobilities
